Walk-Trot: For riders any age and years in 4-H, who are not ready to lope or canter in competition. No cross-entering - must enter "Walk-Trot" for ALL classes, all day. **Not** for experienced riders on "green" horses.

Jr. - 3rd - 5th grade (this past school year) **Int.** - 6th - 8th. **Sr.** - 9th - 12th.
